What is the purpose of this update?

This document tells you how the Simplicity NZ Share Fund (NZ Share Fund) has performed and what fees were charged. The document will help you to compare the fund with other funds. Simplicity NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The NZ Share Fund invests in securities listed on the New Zealand stock exchange (NZX), designed to be the New Zealand share component of a diversified investment portfolio.

What are the risks of investing?

Risk indicator



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

As the fund has not been in existence for five years, the risk indicator is based on five year information including actual performance figures from 3 April 2018, and market returns data for the period prior to that date. As a result of this, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Mia had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Mia received a return after fund charges were deducted of \$2,973 (that is 29.73% of her initial \$10,000). Mia also paid \$30 in other charges. This gives Mia a total return after tax of \$2,943 for the period.

Notes

1. As the fund started on 3 April 2018, actual returns for the fund are not available until then. To calculate the risk indicator for the five-year period ending 31 December 2019, market index returns have been used up to 31 March 2018 with actual fund returns used for the balance of the period. As a result of those market returns, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.
