#### What is the purpose of this update?

This document tells you how the Simplicity Growth Investment Fund (Growth Fund) has performed and what fees were charged. The document will help you to compare the fund with other funds. Simplicity NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### **Description of this fund**

The Growth Fund provides investors with a limited exposure to income assets, but most of its investments are in growth assets. As a result, the return from the Fund is likely to be higher over the longer term (10 years or more) than the Balanced or Conservative Funds, but the value of its investments is likely to fluctuate more than the Balanced or Conservative Funds.

#### What are the risks of investing?

#### **Risk indicator**



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Small differences in fees and charges can have a big impact on your investment over the long term.


Mia had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Mia received a return after fund charges were deducted of \$2,086 (that is 20.86% of her initial \$10,000). Mia also paid \$30 in other charges. This gives Mia a total return after tax of \$2,056 for the period.

The top ten investments make up 80.19% of the fund. The fund's exposure to assets denominated in foreign currencies was 67.36%, of which 71.39% was hedged. This means the fund's unhedged foreign currency exposure was 19.27% of the net asset value of the fund.
