



# Fund update

## What is the purpose of this update?

This document tells you how the Simplicity Balanced Investment Fund (Balanced Fund) has performed and what fees were charged. The document will help you to compare the fund with other funds. Simplicity NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

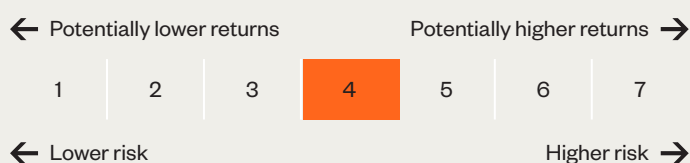
The Balanced Fund provides investors with an exposure to a mix of growth and income assets. As a result, the return from the Fund is likely to be lower over the longer term (10 years or more) than the Growth Fund, but the value of its investments is likely to fluctuate more than the Conservative Fund.

## What are the risks of investing?

Risk indicator for the Balanced Fund<sup>1</sup>:

### Risk indicator



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

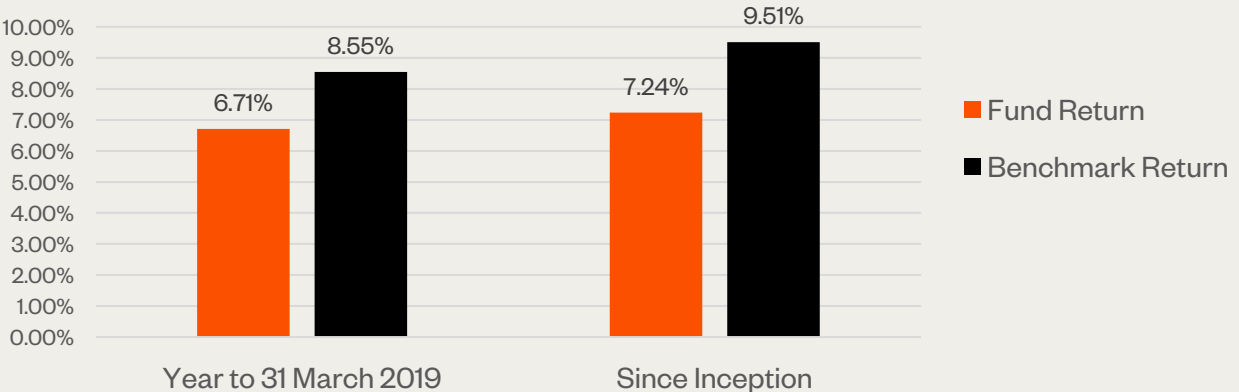

## Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

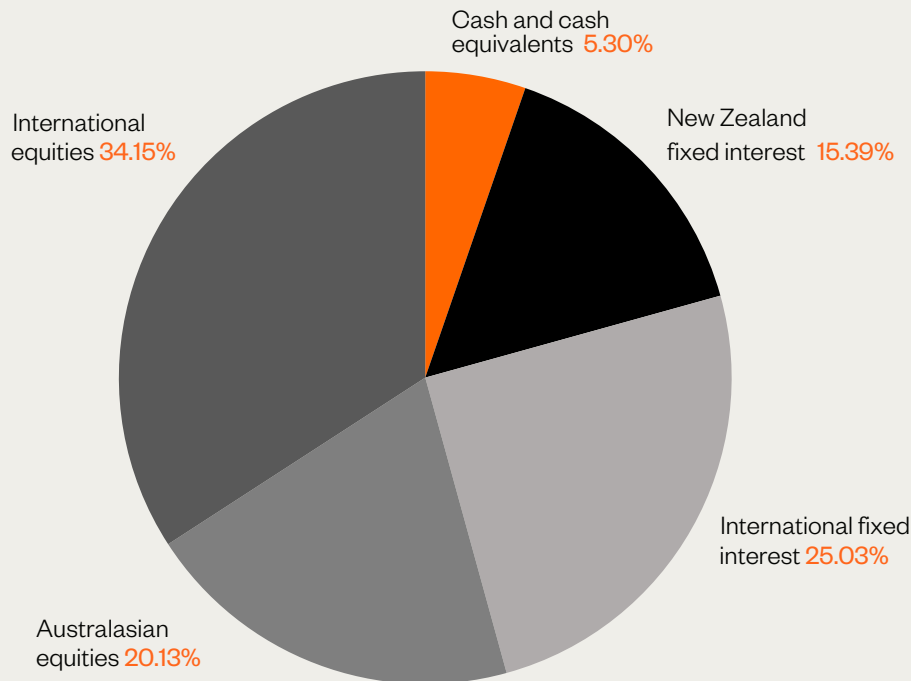
Mia had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year Mia received a return after fund charges were deducted of \$1,598 (that is 15.98% of her initial \$10,000). Mia also paid \$30 in other charges. This gives Mia a total return after tax of \$1,568 for the period.

The top ten investments make up 78.70% of the fund. The fund's exposure to assets denominated in foreign currencies was 64.76%, of which 78.56% was hedged. This means the fund's unhedged foreign currency exposure was 13.88% of the net asset value of the fund.

## Notes

1. As the fund started on 3 April 2017, actual returns for the fund are not available until then. To calculate the risk indicator for the five-year period ending 31 December 2019, market index returns have been used up to 31 March 2017 and the actual fund returns for the balance of the period. As a result of those market returns, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.
2. Other management and administration charges include a 0.01% estimated fee which covers administration costs incurred by the Vanguard underlying funds. This estimate is based on actual annual costs reported by Vanguard in its most recent annual report dated 30 June 2019 with additional details provided by Vanguard, and anticipated investment levels in the underlying funds in accordance with the Scheme's SIPO.
